Letters of recommendation should be written on your behalf by Beaverhead County High School staff and community members; including at least one such letter which must substantiate your community involvement. **The essay portion of the application (not to exceed one typed page) should discuss the responsibility of an individual to serve one's community.** Please be sure to sign and date your application.

SUBMISSION

A completed application must include the following:

- The completed, signed, and dated application
- A copy of your most recent certified BCHS transcript
- Letters of recommendation for this Scholarship on your behalf from teachers, community leaders and others
- A one-page (typed) essay detailing your view on the importance of community service as well as your personal experiences
